

為聘請額外老師於各級推行小班教學，本校於 2015/16 學年開始向每位學生徵收特別費用。在過去三學年進行之全校學生問卷調查中，超過 70%同學認為課堂上老師與學生、學生與學生之間的互動足夠，以及課堂上老師對學生的關顧足夠，有關百分比持續上升；教育局之持分者問卷調查中，學生於「老師關心我」這題過去三年之分數分別為 3.7、3.7、3.8 (最高 4 分)，高於之前 4 年的平均分(3.5)，而本校於過去三年之中學文憑試中，獲取 4 級、5 級、5*級及 5**級之百分比，亦較之前 4 年有更進一步之提升，上述結果令人欣喜，我們會於以上範疇繼續自我完善。經本校家長教師會通過，按着通脹及公務員薪酬調整幅度 (約 4.5%)，本學年每位中一至中五學生需支付\$1,692，每位中六學生需支付\$1,128。如學生中途退學，將會按學生就讀時間之比例計算學生應繳付之費用。有關本學年的收費安排如下：

領取綜援的高中學生	家長可憑收據向社會福利署申請退回其中\$320 之堂費，故中四至中六學生只需在 10/10/2018 繳付\$320，其餘獲豁免之費用由法團校董會及校友的捐款支付。由於需符合核數要求，有關學生需於 <u>7/9/2018 或以前呈交證明文件副本</u> 予戴建輝副校長作校方存檔之用
領取全額書簿津貼學生	全數豁免，有關費用由法團校董會及校友的捐款支付。由於校方已獲學生資助處提供相關名單，故不用提交任何證明文件
領取半額書簿津貼學生	豁免百份之五十，中一至中五學生在 10/10/2018、10/1/2019 及 10/5/2019 分三期繳付，每期 \$282；中六學生在 10/10/2018 及 10/1/2019 分兩期繳付，每期 \$282。餘下費用由法團校董會及校友的捐款支付。由於校方已獲學生資助處提供相關名單，故不用提交任何證明文件
其他特殊情況	凡經校方批核者，校方會個別通知有關家長繳費的安排。獲豁免之部份或全部費用由法團校董會及校友的捐款支付。

第一期費用將於 10/10/2018 從繳費靈戶口中扣除。若 台端每次只存入需繳付的準確款項，務必多存入\$ 2.2，以免在扣除行政費後，戶口沒有足夠結餘支付費用。已獲豁免以現金或支票繳付者，請於 7/9/2018 把費用交班主任（支票抬頭為「沙田崇真中學法團校董會」）。請於 4/9/2018 或以前回覆，以示 台端已知悉有關通告內容。若 台端經提示後仍沒有回覆，校方視台端已知悉有關通告內容。 台端如有任何查詢，歡迎致電學校（電話：2607 3881）聯絡本人或戴建輝副校長。

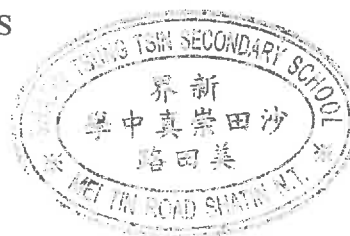

The School has started collecting charges for specific purposes from each student since the academic year 2015/16 to deploy additional teachers so as to implement small-class teaching at all levels. Over the past three years, a whole school survey was conducted and the results were promising. Over 70% of the students agreed that the teacher-student and student-student interaction in class, as well as teachers' concern given to students were enough. The aforesaid percentages have kept increasing in the past three years. In the student stakeholder survey requested by EDB, the marks of the question "The teachers care about me" in last three years are 3.7, 3.7 and 3.8 (the maximum is 4), which was higher than the average of the previous four years' figures (3.5). The percentages of attaining Level 4, Level 5, Level 5* and Level 5** in the HKDSE have increased in past three years too. We will continue to strive for excellence in the above domains. Having considered the inflation rate and the civil service pay adjustment (around 4.5%) and being passed by the Parent-Teacher Association, each S1 to S5 student has to pay \$ 1692 while each S6 student has to pay \$ 1128 in this academic year. If students withdraw before the end of the school year, the amount they have to pay will be proportionate to the length of their studies. The arrangement of collecting the charges is as follows:

Student's financial status	Arrangement
S1-S5 students not receiving any government subsidy	In 3 payments with each payment of \$564, make one payment each on 10/10/2018, 10/1/2019 & 10/5/2019
S6 students not receiving any government subsidy	In 2 payments with each payment of \$564, make one payment each on 10/10/2018 & 10/1/2019
S1-S3 students receiving Comprehensive Social Security Assistance	Total exemption and the payments will be made by donation from the school sponsoring body and alumni. In order to meet the audit requirements, students concerned have to submit a copy of the relevant document to Mr. Tai, the Vice-principal, on or before 7 September, 2018 for filing purpose
S4-S6 students receiving Comprehensive Social Security Assistance	Can get a refund of \$320 for Tong Fai from the Social Welfare Department on production of the school receipt and hence S4 – S6 students have to make one payment of \$320 on 10/10/2018. The rest will be made by donation from the school sponsoring body and alumni. In order to meet the audit requirements, students concerned have to submit a copy of the relevant document to Mr. Tai, the Vice-principal, on or before 7 September, 2018 for filing purpose
Full-grant students under the School Textbook Assistance Scheme	Total exemption and the payments will be made by donation from the school sponsoring body and alumni. As a list of students concerned has been provided by the Student Finance Office, students concerned need not submit any proof.
Half-grant students under the School Textbook Assistance Scheme	Paying half of the charges and the rest will be made by donation from the school sponsoring body and alumni. S1-S5 students have to make one payment each of \$282 on 10/10/2018, 10/1/2019 & 10/5/2019 while S6 students have to make one payment each of \$282 on 10/10/2018 & 10/1/2019. As a list of students concerned has been provided by the Student Finance Office, students concerned need not submit any proof.
Other special cases	The School will inform parents concerned in person of their payment arrangement. The charges exempted will be made by donation from the school sponsoring body and alumni.

The first payment will be withdrawn from the PPS account on 10/10/2018. If you deposit only the exact amount for each required payment, you should deposit an extra \$ 2.2 so as to ensure that the balance in your account is sufficient enough to settle the payments including the administrative cost. Those who have been exempted from using PPS account have to submit the cash and cheque (payable to "The Incorporated Management Committee of Shatin Tsung Tsin Secondary School") to the form teacher on 7/9/2018. Please reply on or before **4/9/2018** to show that parents are aware of the information given in the notice. If parents do not reply after being reminded, they will still be considered as being aware of the information given in the notice.
